As a parent of St. Agatha Catholic School, you are encouraged to be an active parishioner and parent.

It is important that you demonstrate the following:

- ☐ Be a registered parishioner of St. Agatha Parish (or sister parish) and participate in the faith life of the parish by giving fully of time, talent, and treasure.
- ☐ Regularly attend Sunday Mass and Days of Obligation Masses.
- ☐ Volunteer at least 20 hours of service to the school and/or parish community.

Tuition is payable each month through the FACTS tuition payment system. **All tuition payments are non-refundable.** **The first tuition payment is due May 22nd of the current school year.** Nine subsequent payments are due from September through May. A late charge of \$100.00 will be assessed when payment is delinquent.

Registration is payable at time of enrollment.

TUITION

TUITION PAYMENT PLAN: Tuition is collected in 10 installments throughout the year through the FACTS tuition system. A late fee of \$100.00 will be charged for each delinquent payment which exceeds 10 days after due date. Tuition payment #1 is due on May 22 of current school year. All payments are non-refundable. Tuition payment # 2-10 are due September 2026 – May 2027.

SECURITY FEE: A security fee of \$300.00 per student will be assessed to hire a full-time police officer. A charge of \$150.00 per student will be charged via FACTS on July 1st and November 1st.

DEVELOPMENT PLAN FEE: A \$500.00 development plan fee per family will be assessed to finance major school maintenance and improvement projects. A charge of \$250.00 will be charged via FACTS on October 1st and March 1st.

iPad FEE: An iPad rental fee for \$120.00 for grades 5th-8th (including PPB, PPC, and PPD) will be charged via FACTS on May 18th.

YEARBOOK FEE: Every family will receive one yearbook highlighting our students and school community. A \$50.00 fee per family will be charged via FACTS April 1st.

ATHLETIC PROGRAM TEAM REGISTRATION FEE: The fee assessed for a student who chooses to participate in a team sport through the athletic program is \$50.00 per team sport.

DISCOUNTS / REDUCTIONS

PRE-KINDERGARTEN STUDENT WITH SIBLING: Discount applies for a Pre-Kinder level student who has a sibling(s) in Kinder to 8th grade.

MULTI-STUDENT: Discount applies for students from Kinder to 8th grade. **Students in Pre-Kinder and the special education programs are excluded from this discount. Full tuition applies.**

THIRD PARTY SCHOLARSHIP: We accept Step-Up, Family Empowerment and AAA Scholarships from the state of Florida for Kinder-8th grade students. It must be understood however, that if the scholarship is less than our annual tuition, the parents will be assessed the difference.

Additional Services: Students in need of additional services may be assessed for those services.

ACTIVE PARISHIONER: Active St. Agatha Church parishioners who participate in the faith life of the parish by regularly attending Sunday Mass and Holy Days of Obligation and by giving fully of time, talent and treasure may be eligible for a discretionary tuition discount.

IMPORTANT:

The parent must submit the required form letter to receive the active parishioner discount. The documentation must be submitted by May 1st of current school year in order to receive the active parishioner discount the following school year.

ACTIVE SCHOOL PARENT: Active school parents who attend Home and School meetings, work at the Home & School events, serve as homeroom parent, attend St. Agatha retreats, etc.... are eligible for a discretionary tuition discount the next school year. In order to volunteer in any activity during parish and school events in which children are present fingerprint clearance and Virtus training are required. Active school parents will receive a discretionary tuition discount (maximum of \$200.00) the following school year.
